Please complete the entire form. Applications must be completed and received **before 12pm** on Friday 3 August at UCSA reception. Late nominations will NOT be accepted.

You must also email **a blurb and a photo** before nominations close. President blurbs must be a maximum of 800 words, Vice President and Finance blurbs must be a maximum of 400 words, and any other position must be a maximum of 200 words. If you are running for multiple positions, please submit a blurb only for the "highest" role. Failure to do so within the time frames will mean that your blurb and photo may be left out of any UCSA driven publicity. Please email the blurbs and photo to returningofficer.uca@gmail.com.

Candidates may apply for more than one position; however they can only hold **ONE position**. Candidates who are voted in to more than one position will be elected to the highest polled position (see over the page for more details).

Candidates, and their nominees in completing this form certify that they are a UCSA member, or will be a UCSA member at the time nominations close. Check your UCSA student membership at the UCSA reception with your Student ID.

In order for a nomination for President to be valid, the following conditions shall be satisfied;

1. The candidate has not already held the office of President for two or more years; and
2. The candidate must have been enrolled for at least one academic year at the University of Canterbury directly prior to the year they first take office.

Nominations for President, Vice President and Finance Officer **must include a signed copy of the job description**.
